Bail Bonds

Coverage is provided for bail bonds associated with an accident that results in bodily injury (BI) or property damage (PD).



Cell Phone

Coverage for direct physical loss or damage to your cell phone while in your covered vehicle (similar to the insurance that cell phone carriers offer).



Customizing Equipment

Coverage in the event there's a loss to custom equipment on your covered auto.



Death Indemnity

Coverage to a relative or an estate in the event of an insured's death.



Emergency Ambulance

Coverage for emergency ambulance transportation related to an accident that results in bodily injury (BI).



Emergency Travel

Coverage for lodging, meals, and/or transportation if you have a loss or breakdown of your covered auto.



First Aid to Others

Coverage resulting from providing first aid to others at the scene of an accident involving liability coverage.



GPS Coverage

Coverage for direct physical loss or damage to your GPS while in your covered vehicle (only applies to devices that are not permanently installed).



Increased Transportation Expense

An increase to the daily coverage limit for alternate transportation due to a covered loss on your vehicle.



Locksmith/Key Replacement

Coverage for locksmith services or replacement of electronic key if keys are lost or stolen.



Pet Coverage

Coverage for reasonable vet bills or a death benefit for injury or death of an owned pet due to an accident in a covered vehicle.



Personal Effects

Coverage for loss of personal effects in your covered auto due to lightning or fire.



Reasonable Attorney Fees

Coverage for reasonable attorney fees in the event of your arrest for an accident causing bodily injury.



Rented Vehicle Coverage

Coverage for vehicles you're renting for less than 90 days — we'll even help cover the cost to repair a rental vehicle if you damage the vehicle and we also include loss of use and diminution of value.



Total Disability

Coverage for lost wages due to continuous total disability caused by bodily injury in an accident.



Waiving of Deductible for Collision

Deductible may be waived when damage exceeds your deductible.



Waive Deductible Uninsured Motorist Property Damage (UMPD)

Deductible will be waived when damage is caused by an uninsured motorist and UMPD coverage is applicable.



Waiving of Deductible for Other Than Collision (OTC)
